

ORDINANCE NO. 2019-018-PR

**AN ORDINANCE TO AMEND ORDINANCE 2013-001-PR
TO ADD AN ADDITIONAL POSITION ON THE
PARK AND RECREATION BOARD**

WHEREAS, the Park and Recreation Board of the City of Trussville provides a great benefit to the City in continually observing, evaluating and making recommendations for park programs for our citizens; and

WHEREAS, the City Council, at the recommendation of the Park and Recreation Board, has determined that removing two positions on this Board is in order, and that said reduction in membership will not adversely affect the activities and programs conducted under the Park and Recreation umbrella..

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Trussville, Alabama, that Section 4. Membership is amended as follows:

Section 1. The membership provisions of Ordinance 2013-001-PR shall be amended as follows:

Section 4. MEMBERSHIP: The Board shall consist of seven (7) members.

A. Members shall be appointed by majority vote of the City Council. Terms of office shall be four (4) years, and shall be staggered to allow for two vacancies to occur on February 28 of three calendar years, and one vacancy to occur on February 28 of the fourth calendar year. As terms of members expire, their successors shall be appointed for terms of four (4) years each. Vacancies in unexpired terms shall be filled by the City Council in the same manner as original appointments are made; replacement appointees shall serve for the remainder of the unexpired term to which they are appointed.

B. Members may be reappointed. Members shall serve without compensation, but may be reimbursed for actual expenses incurred in the service of the Board with approval of the City Council. Members may be removed for cause by the Mayor. Further, any member missing four (4) consecutive monthly meetings may be removed by the Mayor.

D. The Councilperson over Parks and Recreation shall attend Board meetings and report the actions of the Board to the City Council as necessary. The Council liaison shall not be a voting member of the Board. The term of the Council liaison shall coincide with his or her term of office.

Section 2. REPEALER: All ordinances or parts of ordinances heretofore adopted by the City Council of the City of Trussville, Alabama which are inconsistent with the provisions of this Ordinance are hereby expressly repealed.


Section 3. SEVERABILITY: If any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect notwithstanding such holding.

Section 4. EFFECTIVE DATE: This ordinance shall become effective immediately upon adoption and publication as provided by law.
