NOVEMBER 24, 2020 REGULAR SESSION

The City Council of the City of Trussville met in regular session on Tuesday, November 24, 2020 at 6 pm at Trussville City Hall, with Council President Alan Taylor presiding over the meeting and City Clerk Dan Weinrib serving as recording secretary.

Taylor called the meeting to order. Taylor led the prayer. Short led the pledge to the flag.

After reviewing the minutes from the November 5 workshop and November 10 regular session, Short moved and Bright seconded the motion to approve all minutes as originally drafted.

UNANIMOUS

Taylor introduced the agenda & consent agenda. He then requested that the Council approve the agenda and consent agenda as submitted. Short moved and both Bright & Anderson seconded the motion. **UNANIMOUS**

During public comments, Richard Epstein (4742 Boulder Dr) made a variety of suggestions. Malcolm Lehr (388 Brentwood Ave) requested that the city reduce the volume from the downtown pavilion's loudspeakers.

Taylor introduced a drafted proclamation honoring Don Evans' 18 years of service on the city utilities board. Bright moved and Short seconded the motion. Taylor presented the framed proclamation to Evans. **UNANIMOUS. Proclamation 2020-17**

Short then introduced proposed ordinances recommended by the Planning & Zoning Board.

Short moved and Bright seconded the motion for unanimous consent to immediately consider a proposed ordinance. **UNANIMOUS** Short then moved and Anderson seconded the motion to approve the proposed ordinance that would expand the Downtown Overlay District & Map. **UNANIMOUS. Ordinance 2020-040-PZ**

Short moved and Bright seconded the motion for unanimous consent to immediately consider a proposed ordinance. **UNANIMOUS** Short then moved and Anderson seconded the motion to approve the proposed ordinance that would allow retail outdoor displays as exceptions to the current retail zoning ordinance. **UNANIMOUS. Ordinance 2020-041-PZ**

Short moved and Bright seconded the motion for unanimous consent to immediately consider a proposed ordinance. **UNANIMOUS** Short then moved and Anderson seconded the motion to approve the proposed ordinance that would annex 425 Mobile Avenue into the city. **UNANIMOUS. Ordinance 2020-042-ANX**

Bright moved and Short seconded the motion to approve a drafted longevity pay schedule for city & utility employees. **UNANIMOUS. Resolution 2020-112**

Bright moved and Short seconded the motion to approve a drafted city holidays schedule. **UNANIMOUS. Resolution 2020-113**

Anderson moved and Bright seconded the motion to approve a drafted 2021 city council regular session schedule. **UNANIMOUS. Resolution 2020-114**

Anderson moved and Bright seconded the motion to approve Bryant Bank as the depository for various city accounts. **UNANIMOUS. Resolutions 2020-115, -116, -117 & -118**

Anderson, Bright, Short, Taylor and Choat each gave reports on their respective portfolio assignments.

There were no comments from the audience.

The Council then adjourned its regular session at 6:43 pm with Iron Bowl rivalry wisecracks.
