ORDINANCE NO. 2021- OIO - ADM

AN ORDINANCE ESTABLISHING THE BOARD OF DIRECTORS OF TRUSSVILLE CEMETERY REHABILITATION AUTHORITY

WHEREAS, in accordance with § 11-47-and § 11-80-13 40 of the <u>Code of Alabama</u>, as amended, on or about January 21, 2021, under Ordinance No. 2021-005-ADM, it was ordained by the City Council of the City Of Trussville, Alabama, that the Trussville Cemetery Rehabilitation Authority be formed as a non-profit public corporation under the laws of the State of Alabama and the Code of Ordinances of the City of Trussville, Alabama; and

WHEREAS, it was further ordained that that the Board of Directors of the Trussville Cemetery Rehabilitation Authority be created and that five (5) members be nominated by the Mayor and submitted to the City Council for approval; and

WHEREAS, it was determined that the initial terms of the Board of Directors shall begin after nomination by the Mayor and appointment by the City Council and shall expire as follows:

Board Member One – Term of one (1) year;

Board Member Two - Term of two (2) years;

Board Member Three - Term of three (3) years; and

Board Members Four and Five- Term of four (4) years.

WHEREAS, the Mayor has deliberated and determined that he would like to nominate the following individuals for appointment to fill the newly created Board of Directors of the Trussville Cemetery Rehabilitation Authority. These initial members are:

- (1) Pat Glenn;
- (2) Eric Frederick;
- (3) John Patterson;
- (4) Jaime Melton Anderson; and
- (5) Gary Lloyd.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TRUSSVILLE, ALABAMA, that the following individuals shall be radified and appointed to the Board of Directors of the the Trussville Cemetery Rehabilitation Authority:
