During public comments, Veterans Committee member John Griscom announced that he and other volunteers will lay 1100 wreaths at gravesites of veterans here in Trussville at 11 am on December 18<sup>th</sup> as part of Wreaths Across America Day. Fellow committee member Jim Wolfe commended the local chamber of commerce for organizing a successful Christmas parade.

Councilor Bright introduced a proposed proclamation honoring her former neighbor Teddy Gilmer for his service on the Utilities Board and our community. She, Mayor Choat and Council President Cook added their own words of praise. She moved and Councilor Short seconded the motion for approval. **UNANIMOUS. Proclamation No. 2021-29** 

After a brief recess for a group photo with Teddy & Imelda Gilmer, Council President Cook resumed the meeting.

Councilor Short moved for unanimous consent for immediate consideration of a proposed ordinance. Councilor Bright seconded the motion. **UNANIMOUS.** He then moved to approve an ordinance for annexing 118 Pamela Drive. Councilor Bright seconded the motion for approval. **UNANIMOUS. Ordinance No. 2021-032-ANX** 

Councilor Bright introduced a proposed resolution to create a three-member city public building authority, with John M. Amari, Jeremy W. Tuggle and Sidney Gayle McNeal Jr. serving as its members. Councilor Short seconded the motion. **UNANIMOUS. Resolution 2021-67** 

Councilor Short then introduced a proposed resolution to award the library janitorial services bid to Office Pride Commercial Cleaning. UNANIMOUS. Resolution No. 2021-68

All three councilors postponed their reports. Upon recognition by Council President Cook,

Building Inspections Chief J.R. Malchus announced that the City's 2022 Storm Water Management Program Plan, aka SWMPP, is available on the city's website for public review, prior to the next council meeting.

Mayor Choat complimented the Chamber on its Christmas parade. He announced that both Wreaths Across America and the ceremonial groundbreaking for the future Alabama Fallen Warriors Memorial take place on Saturday December 18. Also, he and Public Works Director Wayne Sullivan are still trying to get updates from ALDOT regarding US-11 repaving. Also, Alabama Power announced it will light or re-light interstate highway lamps throughout the Birmingham metro area soon, so hopefully Trussville will benefit from that action soon. Some poles do belong to the City.

There were no audience comments.

With no further public business, the Council promptly adjourned at 6:21 pm.
