## ORDINANCE NO. 2021-435-ADM

An Ordinance to Amend Section 18-65 License Classifications With Regards to Yard Sales & Certain Mobile Food Service and Section 18-66 License Fee Schedules With Regards to Certain Mobile Food Service, Insurance Companies & Rental Property

BE IT ORDAINED by the City Council of Trussville Alabama while in regular session as follows:

**Section 1.** Section 18-65 – License Classifications, NAICS Code 454390 definition is hereby amended to read "PEDDLERS, ice cream, peanuts, sandwiches, donuts, etc. delivered by basket, handcart or truck, direct selling, tables, tent, non-cooked and packaged food; yard or garage sales"

Section 2. Section 18-66 is hereby amended to read

"\*\* Yard or garage sales shall only take place at the residence, in accord with all other City
Ordinances. There shall be no more than four (4) yard or garage sales occurring over any twelve(12-) month period at any one residential address. At no time shall any yard or garage sale event
operate longer than three (3) consecutive calendar days. There shall be no permit fee for yard or
garage sales. All yard or garage sales should be registered with the Inspections Department."

- "Insurance Agent—\$150.00 plus an amount equal to 1/5 of 1% (.002) of gross commissions in excess of \$50,000.00.
- "Insurance Adjuster—\$150.00 plus an amount equal to 1/5 of 1% (.002) of gross fees for services rendered in excess of \$50,000.00.
- "Insurance, Fire and Marine—Pursuant to Code of Ala. 1975, § 11-51-120—\$4.00 on each \$100.00 or major fraction thereof of gross premiums, including renewals when such renewal includes additional property or persons within its coverage at the time it is renewed, provided that new companies shall pay a flat minimum license of \$50.00 for the first year on which there shall be an adjustment at year end.
- "Insurance, Other than Fire, Marine and Fraternal—Pursuant to Code of Ala. 1975, § 11-51-121—\$20.00 plus \$1.00 on each \$100.00 and major fraction thereof of gross premiums, including renewals when such renewal includes additional premiums.
- "Insurance Brokers and Insurance Activities Not Listed Elsewhere —\$150.00 plus an amount equal to 1/5 of 1% (.002) of gross fees for services rendered in excess of \$50,000.00."

"Schedule "Y"—Rental Property—Residential, Commercial, Mini-Warehouses, and Telecommunications Towers

Minimum license fee shall be \$150.00 plus 1/10 of 1% (.001) of gross receipts of such rentals

Note: Each individual who rents or leases to no more than one tenant or joint tenant on a single lease agreement, one residential dwelling unit or house, owned or controlled by said individual, shall be exempt from this license.

**Section 3.** Severability: If any part, section, or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect notwithstanding such holding. If any part, section or subdivision of this ordinance or document, map, or petition to which it may refer shall be held unconstitutional or invalid as to any portion of the territory annexed herein, such holding shall not be construed to impair or invalidate the ordinance as to the territory not included in or affected by such holding.

**Section 4.** Repealer: All ordinances or parts of ordinances heretofore adopted by the City Council of the City of Trussville, Alabama which are inconsistent with the provisions of this ordinance are hereby expressly repealed.

**Section 5.** This Ordinance shall be effective on January 1, 2022.
