## **JANUARY 19, 2023 AGENDA WORKSHOP**

Members of the City Council met in a **workshop session** on **Thursday, January 19, 2023,** at 5 pm at the City Hall Annex. to review the proposed agenda for its next regular session. Council President Lisa Bright presided over the meeting and Dan Weinrib acted as recording secretary.

The City Council then determined the order of consideration for its upcoming agenda. Councilors Anderson and Short informed their peers and public that they would not be in attendance for the upcoming meeting. With no further business to discuss, the workshop adjourned at approximately 5:20 pm.

## **JANUARY 24, 2023 REGULAR SESSION**

The City Council of the City of Trussville met in **regular session** on **Tuesday, January 24, 2023** at 6 pm at the City Hall Annex, with Council President Lisa Bright presiding over the meeting and City Clerk Dan Weinrib serving as recording secretary.

President Bright called the meeting to order. Councilor Cook led the prayer. Councilor Taylor led the pledge to the flag.

They reviewed minutes from the January 10th agenda workshop and regular session. Councilor Taylor moved and Councilor Cook seconded the motion for approval. **UNANIMOUS** 

President Bright then introduced the regular agenda and consent agenda. Councilor Taylor moved and Councilor Cook seconded the motion to approve the consent agenda **UNANIMOUS** Before proceeding further, President Bright recognized Mayor Choat, who requested an executive session at the end of the public meeting to discuss possible real estate transactions and potential litigation. Councilor Taylor moved and Councilor Cook seconded the motion to approve the regular agenda, with the executive session noted. **UNANIMOUS** 

There were no public comments.

Under the regular agenda, President Bright recognized Police Chief Eric Rush. Chief Rush summoned newly promoted Police Corporals David Warmus, James McCool, Scotty Bates, Michael Montana & Casey Davis. He praised each man for his contributions to policing and briefly described how their roles have changed with their promotions. After a brief recess for photographs, President Bright continued the meeting.

Councilor Taylor then introduced a proposed proclamation honoring the Hewitt-Trussville Middle School Girls Bowling Team. The five-member squad went 12-0 in its second year of existence. They finished their season by winning the Metro Tournament earlier in January. He moved and Councilor Cook seconded the motion for approval. **UNANIMOUS Proclamation No. 2023-01** After a brief recess for photographs, President Bright continued the meeting.

President Bright opened a public hearing for a proposed alcohol license for Moes Original BBQ on Main Street. District Manager Cody Sellers represented his employer. He oversees the four Birmingham area Moes restaurants. Moes wants to sell beer for on-premises-only consumption. He confirmed that Moes requires all servers to complete the Responsible Vendor Training and to ask for identification from all

customers ordering alcohol, even from septuagenarians. Councilor Cook wanted and received confirmation that beer sales were strictly for on-premises consumption. Since nobody in the audience spoke up, President Bright promptly closed the public hearing.

Councilor Cook then introduced a resolution approving the alcohol license for Moes Original BBQ. He moved and Councilor Taylor seconded the motion. **UNANIMOUS Resolution No. 2023-02** 

Councilor Taylor then introduced a resolution adopting the FEMA Division G Multi-Jurisdictional Hazard Mitigation Plan. A federal law passed in 2000 requires annual adoption by participating cities. He moved and Councilor Cook seconded the motion for approval. **UNANIMOUS Resolution No. 2023-03** 

There were no audience comments.

Councilor Taylor then made the motion, which Councilor Taylor seconded, to go into executive session to discuss possible real estate transactions and potential litigation. **UNANIMOUS** 

They went into executive session at 6:23 pm. Upon its conclusion and with no further public business, they promptly adjourned at 6:30 pm.
