- Have other projects that need funding: Loop Road project, Glendale Farms, etc.
- Met with Game Day (turf company) regarding starting a project in the park (starting with the baseball and softball fields)
- In the spring there are not enough fields for make-up games and practices
- Talked about converting one of the existing fields to a miracle league field to be used for tball field with a rubberized surface
- Had 650 kids in baseball this year
- The multi-purpose field behind the athletic building at Middle school will be ready when school starts which will be used for football, soccer, and lacrosse
- Having more fields addresses the community need and allows Trussville to host more tournaments (if had more multi-purpose fields)
- Will put together a master plan for the park
- Pickle Ball courts in Sports Complex everything will be completed by next week
